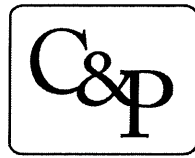

NOTE 1 – NATURE OF ACTIVITIES AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Nature of Activities – United Cerebral Palsy Association of Central Arizona, Inc. (Association), an Arizona nonprofit corporation, is a private rehabilitation and training facility. The Association promotes the general health and welfare of Arizonans with cerebral palsy and related developmental disabilities. The Association executes contracts annually with the Arizona Department of Economic Security and other groups to provide a variety of services. The Association also obtains funding from the general public, corporations, and institutions through fundraising activities, donations, and bequests.

The accounting policies of the Association conform to generally accepted accounting principles of the United States of America as applicable to nonprofit organizations. The following is a summary of the more significant accounting policies:

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting and, accordingly, reflect all receivables, payables, and other liabilities. Net assets and revenues, expenses, gains, and losses are classified based on the existence or absence of donor-imposed restrictions in accordance with generally accepted accounting principles. Accordingly, net assets of the Association and changes therein are classified and reported as follows:

Unrestricted net assets – Net assets that are not subject to donor-imposed stipulations

Temporarily restricted net assets – Net assets subject to donor-imposed stipulations that may or will be met, either by actions of the Association and/or the passage of time. When a restriction expires, temporarily restricted net assets are reclassified to unrestricted net assets and reported in the statement of activities as net assets released from restrictions.

Permanently restricted net assets – Net assets subject to donor-imposed stipulations that they be maintained permanently by the Association. Generally, the donors of these assets permit the Association to use all or part of the income earned on any investments for general or specific purposes.

Property and Equipment – Property and equipment acquired by United Cerebral Palsy Association of Central Arizona, Inc. are stated at cost. Property and equipment received as contributions are stated at estimated fair value on the date received. Depreciation is computed using the straight-line method over the estimated useful lives of the assets ranging from three to forty years.

NOTE 1 – NATURE OF ACTIVITIES AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Continued

Revenue Recognition – Revenues are recognized when earned; gifts and contributions are recognized when received. Bequests and legacies are recognized when title to the fund is established and the amount is determinable. Related costs and expenses are recognized when incurred.

Arizona Department of Economic Security – The Association's contract with the Arizona Department of Economic Security provides for payment of services rendered at negotiated rates. Revenue is recognized when services have been performed.

Insurance and Service Fees – Insurance and service fee revenue is recognized as services are rendered.

Cash and Cash Equivalents – For purposes of the statement of cash flows, the Association considers all cash and other highly liquid investments available for current use with initial maturities of three months or less to be cash equivalents.

Functional Allocation of Expenses – The costs of providing the various programs and other activities have been summarized on a functional basis in the statement of activities. Accordingly, certain costs have been allocated among the programs and supporting services benefited.

Income Taxes – Income taxes are not provided for in the financial statements since United Cerebral Palsy Association of Central Arizona, Inc. is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code and similar state statutes. Furthermore, the Association has been classified by the Internal Revenue Service as a publicly supported organization, and not as a private foundation.

Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events – Management has evaluated subsequent events through the date of issuance of the financial statements, and has determined that there are no significant subsequent events requiring disclosure.

NOTE 3 – INVESTMENTS

Investments consist entirely of marketable securities. Investments in marketable securities with readily determinable fair values and all investments in debt securities are reported at their fair values in the statement of financial position. Fair value measurements at the reporting date are determined using quoted prices in active markets for identical assets (Level 1 fair value hierarchy). Unrealized gains and losses are included in the change in net assets. Investment income and gains restricted by a donor are reported as increases in unrestricted net assets if the restrictions are met in the reporting period in which the income and gains are recognized.

Receivables are recorded at the amount the Association expects to collect on balances outstanding at June 30, 2009 and 2008. Management closely monitors outstanding balances and writes off, as of year end, all amounts considered uncollectible by the time the financial statements are issued.

Accounts receivable past due ninety days or more at June 30, 2009 and 2008, were \$85,928 and \$136,781, respectively.

NOTE 6 – BONDS PAYABLE

During the year ended June 30, 2009, the Association retired the remaining bonds payable to the Industrial Development Authority of the City of Phoenix. Bonds payable consist of the following at June 30, 2009 and 2008:

Interest expense paid on the bonds during the year ended June 30, 2009 and 2008 were \$59,696 and \$106,088, respectively.

NOTE 7 – CONCENTRATIONS

The Association receives a substantial portion of its support from federal and state programs. Contribution of these awards in future years is not guaranteed and the loss of this support may have an effect upon the operation of the Association. For the years ended June 30, 2009 and 2008, the Association received \$5,092,839 and \$5,164,471 of support, respectively, from a contract with the Arizona Department of Economic Security.

The Association has received a substantial portion of its other fund raising support from one contributor for the past twenty years. Contributions from this one contributor are not guaranteed and the loss of this support may have an effect upon its operation. For the years ended June 30, 2009 and 2008, the Association received \$2,337,024 and \$1,902,373, respectively, from this one contributor.

The Association maintains cash deposits at several financial institutions located in Maricopa County, Arizona, which throughout the year regularly exceeds federally insured deposit limits.

The Association maintains accounts with a brokerage firm. The account contains cash and securities. Balances are insured up to \$500,000 (with a limit of \$100,000 for cash) by the Securities Investor Protection Corporation. The stock brokerage firms' accounts carry additional insurance and are insured up to \$50,000,000. At June 30, 2009 and 2008, the money market accounts with the stock brokerage firm were \$1,053,889 and \$340,563, respectively.

NOTE 8 – EMPLOYEE BENEFIT PLAN

The Association sponsors a 401(k) defined contribution plan to provide retirement and incidental benefits for its employees. Employees may contribute up to 15% of their annual compensation to the plan, limited to a maximum annual amount as set periodically by the Internal Revenue Service. The Association matches a portion of each participant's contribution. Association matching contributions to the plan totaled \$56,938 in 2009, and \$37,661 in 2008.
